A Slow Holiday Week for Regulation

Regulatory activity was at a near standstill during the holiday week. Regulators added \$46 million in published burdens, \$121 million in benefits, and more than 1.9 million paperwork burden hours. A final rule on occupant crash protection and a tax measure implementing the Affordable Care Act led the week.

The National Highway Transportation Safety Administration (NHTSA) published a final rule requiring "lap/shoulder seat belts" for passengers in buses. The measure implements the Motorcoach Enhanced Safety Act of 2012 and will impose total costs of \$8.6 million, while generating \$121 million in benefits. The agency

estimates the cost to comply for each bus at approximately \$2,100, which would prevent up to 9.2 fatalities.

AFFORDABLE CARE ACT

The IRS published its final rule imposing a higher Medicare Tax under the Affordable Care Act. The regulation estimates a compliance time of 1.9 million paperwork burden hours.

Since passage, based on total lifetime costs of the regulations, the Affordable Care Act has imposed an estimated cost of \$23.7 billion in private-sector burdens, approximately \$8.5 billion in costs to the states, and 127 million annual paperwork hours.

DODD-FRANK

There were no notable Dodd-Frank rulemakings this week imposing costs or burden hours. Click here to view the total estimated compliance costs from Dodd-Frank; since passage, the legislation has produced more than 62.1 million paperwork burden hours and imposed \$16.4 billion in direct compliance costs. Based on calculations from the Financial Services Roundtable, Dodd-Frank regulations would require 30,303 employees to file federal paperwork.

TOTAL BURDENS

Since January 1, the federal government has published \$96.3 billion in compliance costs and 71.5 million annual paperwork burden hours.
